

Network File Sharing & Managing Large Files and Documents

Advanced Searches

When you need to find information via Column search, you can search all sources including attachments (Word, OCR, Excel, etc.) web pages, emails, and activity logs. More specifically you can perform a search and it will bring back an attachment(s) that contain that keyword. Searches will come back weighted by most probable to least probable.



Personalize interfaces (Theming)

Users can have a specific dashboard as their home screen based on what they would like to see. Also, if the user likes larger or smaller font sizes they will have the option to personalize, as well as the ability to choose specific colors.
